You asked:

Is it possible to provide me with the number of complaints and reports to the council of rodent infestations and sightings across the city?

I'd like the figures broken down by ward, and for the past five years if possible.

Answer:

Please see table below which shows the last five years of requests for treatment, we cannot give sightings of rodents because they are not logged, only as a request for treatment.

We started a Pest Action Zone (PAZ) to cover deprived areas and low income families in 2008. This is where Pest Control targets an area and does a survey of these properties, if an infestation is found they are treated free of charge. We have included these figures at the end.

Unfortunately, we are unable to give you Ward by Ward as we do not have data in Ward format.

As we do not hold some of the information requested this letter also acts as a refusal notice under section 17.1 of the Freedom of Information Act 2000 because, in accordance with section 1.1 of the Act, this information is not held by Leicester City Council.
