

FREEDOM OF INFORMATION ACT 2000

Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

Under FOI I wld like to know the following:

Penalty community notices, fixed penalty notices or traffic tickets given on the junction of clarendon park road and queens road LE2 (or area covering this junction), per month, for the past ten years

Patrol numbers, frequency, and duration at the same junction, over the same period, in same area (or from when council took over, and contracted stipulations when contracted out) Any information on traffic flows and levels in this area over last ten years, and in Leicester as a whole.

ANSWER

Leicester City Council took over Enforcement In 2007 – therefore information can only be provided from this date. This part of this letter acts as a refusal notice under section 17.1 of the Freedom of Information Act 2000 because, in accordance with section 1.1 of the Act, this information is not held by Leicester City Council.

Information provided below is for both roads as an area covering the junction.
