Freedom of Information Act 2000 – Composition of Council Tax Summons costs

Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

"In 1997/98, Summons costs made up 0% (£0) of the total £17 charged to Council Tax payers in obtaining a Liability Order through the Magistrates Court.

In 1998/99, the ratio of the costs changed with Summons costs making up 100% (£18) of the total £18 charged to Council Tax payers.....

In 1999/00, the ratio of the costs remained unchanged with 100% of the total costs £19 being made up of the Summons costs (£19).

In 2001/02, the ratio of the costs remained unchanged with 100% of the total costs £31.65 being made up of the Summons costs (£31.65).

In 2003/04, the ratio of the costs remained unchanged with 100% of the total costs £41.80 being made up of the Summons costs (£41.80).

In 2005/06, the ratio of the costs remained unchanged with 100% of the total costs £44.20 being made up of the Summons costs (£44.20).

In 2006/07, the ratio of the costs remained unchanged with 100% of the total costs £46.50 being made up of the Summons costs (£46.50).

In 2007/08, the ratio of the costs remained unchanged with 100% of the total costs £50 being made up of the Summons costs (£50).

In 2008/09, the ratio of the costs remained unchanged with 100% of the total costs £52 being made up of the Summons costs (£52).

In 2009/10, the ratio of the costs remained unchanged with 100% of the total costs £55 being made up of the Summons costs (£55).

In 2011/12, the ratio of the costs remained unchanged with 100% of the total costs £63 being made up of the Summons costs (£63).

In 2012/13, the ratio of the costs remained unchanged with 100% of the total costs £65.50 being made up of the Summons costs (£65.50).

Q. Please supply, separately and in relation to each review of the summons and liability order costs charged to individual householders in respect of council tax covering the above period;

all information you hold to justify the changes, for example the reason for any change in composition of charges, and/or increases with calculations in support of the changes.

Included in this information would be cabinet documents or similar that would have been necessary to propose the changes and subsequently agree and implement them."

Our response:

Please find attached our costs details since 2001/02. We do not have details of costs and its composition prior to this year. Therefore this part of the letter acts as a refusal notice under section 17.1 of the Freedom of Information Act 2000 because, in accordance with section 1.1 of the Act, this information is not held by Leicester City Council.

All the amounts are made up of summons costs only.

Costs are set at the same level for all the Leicestershire Authorities and are authorised by the Leicester Magistrates' Court (Nick Watson, Justices' Clerk and the Chairman pf the Bench). The base calculation takes place every third year and for the other two years the increase is in line with inflation. The base calculation is taken as an average from four of the Leicestershire Authorities: Leicester City, Oadby & Wigston Borough Council, Rutland and Charnwood Borough Council. Details are only available for 2011/12 and 2014/15, which are attached for Leicester City only.
