

Freedom of Information Act 2000

Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

I refer to recent retrospective planning permission granted to Beaumont Sports Complex Ltd, relating to the developments of sports facilities currently taking place on Beaumont Park.

I note from the recent application and permission (which is a modification of the permission granted in 2010), that actions were required by the leaseholders (BSC Ltd), with a timescale to be agreed upon with Leicester City Council. Can you please advise if those timescales have been agreed yet, and if so what are they? Please also advise the possible outcomes, should those timescales not be fully complied-with.

ANSWER:

Please find the attached copy of the decision. There are two conditions, 2 and 11 which set targets to comply with within three months and two months from the date of decision 15 May 2014. None of these targets have reached yet, therefore there is no breach of planning control occurred.

I re-produce these conditions below:

2. Within three months of the date of this decision, a development programme which shall set out a programme for the bringing into use of the cycle track, the 5 A side pitches and the BMX track, shall be submitted to and agreed in writing with the City Council as local planning authority, and shall be implemented in accordance with the agreed programme. (In the interest of the satisfactory development of the site and in accordance with policies GE09 and PS10 of the City of Leicester Local Plan)

11. Within 2 months of the date of this decision, the acoustic fence shown on the plan reference 130206-100.01 shall be installed and thereafter retained to the satisfaction of the City Council as local planning authority. (In the interests of residential amenity, and in accordance with policy PS10 of the City of Leicester Local Plan)

Leicester City Council would consider enforcement action, if there was a breach of these conditions. The final decision rests with the Planning Committee.
