

## **Freedom of Information Act 2000**

Your request for information has now been considered and the Council's response to your questions is shown below.

### **You asked:**

**My cat xxxx has been missing from xxxx since 6th July around 10pm. He usually comes in to eat his food in the early morning but never showed up which is highly unlike him as we've had him for 6 years and he's never been away from home for more than a few hours.**

**I've been going out everyday calling his name and asking my neighbours/businesses. I've not managed to see him yet however around 7 witnesses have stated that they have seen him come out from the school gates (Catherine Junior School) and then go back inside. As the summer holidays have now started I'm unable to check for myself as the school is closed. I was told by two students that they have seen him inside sleeping too. I wondered whether you would be able to check footage on the following dates and times to help find him as I fear that he has lost his way.**

**06/07/2014 - After 10pm**

**09/07/2014 - 8pm was seen leaving the school gates near the end of Brandon Street where there is a corner shop.**

**10/07/2014 - 8/8.15pm a boy saw him near the school again. There is a brown mobile in the sand park where the old Sainsbury's used to be in Belgrave. Apparently he came out of the brown mobile but was spooked as the boy tried to grab him.**

**14/07/2014 - 6.45 - 7.30am he was again seen leaving the school gates heading towards the corner shop passage way. This time he was seen by 3 people.**

### **Answer:**

Leicester City Council have checked all the CCTV cameras that they have in the area for the time and dates you have provided but there has been no sign of your missing cat. We are sorry that none of the camera's picked up any evidence and hope that he is found safe and sound soon.
