### Average spend on agency staff per year?

The average spend on agency staff over the last three years is £213,801.

There is not an average per year available, as to make an average you need more than one figure to calculate it. So we calculated the average over 3 years, as above.

The Council does not hold this information. Therefore this letter acts as a refusal notice under section 17.1 of the Freedom of Information Act 2000 because, in accordance with section 1.1 of the Act, this information is not held by Leicester City Council.
