A delegated powers certificate was signed off providing the necessary authority to allow partial closure of Victoria Park for the purpose of Leicester Caribbean Carnival on 2nd August 2014. The document is attached.

Please provide the documented evidence of the following-Leicester city council's Deed of Ownership/ or the Lease, in regards to the open Public space known as Victoria Park.

Victoria Park is owned by Leicester City Council and copies of the registered title are available from the Land Registry. This information is accessible elsewhere and therefore is exempt from release under s21 of the Freedom of Information Act.

Please inform us of the date and time when a meeting was held in regards to making a Decision / Resolution to fence the open Public Space known as Victoria Park
