

FREEDOM OF INFORMATION ACT 2000

Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

I write to request an up to date list of subcontractors, suppliers and consultants involved in the demolition of buildings and construction of replacement school together with associated access, parking, landscaping and sports facilities. The associated works include access road, sewer system, infrastructure, enabling works and landscaping.

The site in question is Rushey Mead School and the site address is as follows;

Following a procurement process, that is compliant with European and UK procurement legislation, Leicester City Council on 19 December 2007 formed a Local Education Partnership, called Leicester Miller Education Company Limited, with Miller Consortium Leicester Limited and Building Schools for the Future Investments LLP.

Leicester Miller Education Company Limited has subsequently entered into a contractual relationship with Miller Construction (UK) Limited ("the Contractor") to construct the secondary school premises at Rushey Mead School. The Contractor has been appointed to design, carry out and complete the construction, commissioning and testing of the new school premises on behalf of the Leicester Miller Education Company Limited in accordance with the Agreement. The services detailed in your request are procured through the Agreement with the Contractor.
