Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

The Contractor has been appointed to design, carry out and complete the construction, commissioning and testing of all premises in the BSF programme on behalf of the Leicester Miller Education Company Limited in accordance with the Agreement. The services detailed in your request are procured through the Agreement with the Contractor.
