

Thank you for your email of 14<sup>th</sup> March 2012 where you requested information about Gypsy and Traveller sites. You asked for the following:

**Statistics detailing the number of un-authorized encampments per ward or LPU area broken down by month each year for the last 3 years that occurred within Leicester City District.**

Please see the attached document.

**Any statistics detailing how many of the un-authorized encampment visits that detail repeat visits by the same set of gypsies and/or travellers (again using ward or LPU area and broken down by month each year for the last 3 years)**

This is exempt from release under the Environmental Information Regulations Reg 12(4)(b) and s12 of the Freedom of Information Act. (Manifestly Unreasonable / Exceeds the Limit). The files listed in the attached document would have to be inspected manually to determine repeat visits by visiting travellers. This will take many hours work.

**Evidence of the details that identify the 3 proposed sites as being the ones that best meet the criteria that the thorough search of council owned land identified to have the potential to be authorized sites where the land has been assessed against a range of factors including:**

- . **Potential to be well screened to ensure privacy**
- . **Impact upon neighbours**
- . **Impact on ecology**
- . **Safe pedestrian and vehicle access**
- . **Availability in the short term**

The City Mayor has extended the consultation period until July 13<sup>th</sup> and has published details of the 350 potential sites online. He has also asked the Council's Economic Development, Culture and Tourism Scrutiny Commission to look at the proposals, to ensure the widest possible consideration has taken place.

I can confirm that some of this information may also be information not held. As the sites have not been decided upon, full assessments under the planning process have not been carried out as yet. Once sites are chosen, and

planning applications submitted, further appraisals and consultations will form part of the planning process.

**At the consultation meeting on 12 March 2012, Sir Peter Soulsby kept referring to the proposed sites containing 21 family pitches. However, the current plans show there to be 26 family pitches (across the 3 sites). Please can you explain why there is a discrepancy between the plans and what was said at the consultation meeting of 5 family pitches?**

The total number of potential pitches across all 3 sites total 26 pitches, but funding is only in place for 21. As we have not determined which sites may be chosen yet, we do not know precisely where the 21 pitches may be located across the potential sites. Although we are consulting on 3 sites (26 pitches) there is no guarantee that we will proceed with all 3 sites. So for example if we went forward with two 10 pitch sites we would have near enough the 21 pitches we have funding for. It may also be that following further feasibility work one of the sites cannot accommodate 10 pitches.

**With regard to the current 'temporary' site on Greengate Lane, can you tell me if the people currently residing there pay rent/council tax/licensing fees etc and how much this is per week?**

This information involves the personal information of individual travellers and is exempt from release to you under Reg. 13 of the Environmental Information Regulations and s40(2) of the Freedom of Information Act. This is therefore a refusal notice under s17 of the Freedom of Information Act. I am sorry if this response is disappointing, but to release the personal information of other individuals (e.g. their financial details) could cost the Council a fine from the Information Commissioner's Office under the Data Protection Act 1998.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
