

## **FREEDOM OF INFORMATION ACT 2000**

Your request for information has now been considered and the Council's response to your questions is shown below.

### **You asked:**

**1. How many elderly people living in care homes in your region have been moved from that facility once their funds have fallen below the self-funding threshold? Please indicate the number of people in this position in the last 12 months.**

To provide an evidence based response to question 1 would require a manual trawl of the case files of each placement made in the last 12 months.

However, we can state with a high degree of confidence that the answer is nil. This is on the basis of discussion with head of service and their knowledge of complex casework in their teams.

Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for local government is set at £450. This represents the estimated cost of one person spending more than 18 hours in determining whether the department holds the information, locating, retrieving and extracting the information.

This is therefore a Refusal Notice under section 17.1 of the Freedom of Information Act, because under the provisions of section 12.1 of the Act, the Council estimates that to comply with your request in its current form will exceed the appropriate limit.

You may wish to refine your request by narrowing its scope by being more specific about what information you particularly wish to obtain, including any dates or period of time relevant to the information required. We do have a duty to advise and assist you in refining your request under s16 of the Act so please don't hesitate to contact us if you need help in refining your request.

**2. What form of accommodation were those in that position moved to (ie. Another care home, alternative sheltered accommodation, returned home or to alternative private accommodation)**

**3. If it falls within the cost limit it would be helpful if you can provide comparable data for the previous year**


