

## FREEDOM OF INFORMATION ACT 2000

Your request for information has now been considered and the Council's response to your questions is shown below.

### You asked:

- 1. Please could you advise how many building inspections have been carried out by LCC Building Inspectors since Jan 2009 to date, where the builder carrying out the work is a Builder.**

Unfortunately, the builder's name is not always known to us and there is no search facility available to interrogate our database for this specific information.

In order to check our records we would need to manually trawl through each record which we estimate would take us over the 18 hour limit. Since 01.01.09 we have had 4580 Building Regulation applications and to obtain any such info, each case would have to be opened up, the builder's details field brought up and checked, and then the notes for each inspection (average 7 per case) pulled up individually and checked for content to find this information.

Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for local government is set at £450. This represents the estimated cost of one person spending more than 18 hours in determining whether the department holds the information, locating, retrieving and extracting the information.

We estimate it will take 533 hours to process your request. This is calculated on 32,000 records @ 1 minute per records = 533 hours.

This is therefore a Refusal Notice under section 17.1 of the Freedom of Information Act, because under the provisions of section 12.1 of the Act, the Council estimates that to comply with your request in its current form will exceed the appropriate limit.

You may wish to refine your request by narrowing its scope by being more specific about what information you particularly wish to obtain, including any dates or period of time relevant to the information required. We do have a duty to advise and assist you in refining your request under s16 of the Act so please don't hesitate to contact us if you need help in refining your request.

- 2. Please could you advise the area where the work is being carried out and post codes of the site.**

As per question one.


