Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

What is the councils current policy on twinning that is currently Leicester is twinned with Rajkot can it be twinned with another city in India.

ANSWER

The Council's policy regarding formal twinning arrangements is that new applications are held over and reviewed once per year by the International Development Working Party. Whenever we receive a new request for twinning, we seek the following information:

- 1. Who is proposing the link in the proposed city/town?
- 2. Is there a direct contact in the proposed city/town? Please provide a name and contact details
- 3. Background information on the proposed city/town:
- Location/population/history
- Economy/industry
- What other cities/towns are linked with this city/town?
- Does it have a community-led twinning organisation to support and resource twinning activity?
- 4. What would be the aim/objective of the link?
- 5. What sort of activity would be promoted? Please explain why a permanent, formal twinning arrangement is appropriate rather than a one-off project, or series of time-limited, technical projects?
- 6. Does the proposed city/town have any community links in Leicester?
- 7. Outcomes what would this link achieve for the local authority and the community of the applicant town/city? What would this link achieve for Leicester City Council and the community in Leicester?
- 8. Do you have any anticipated costs in relation to the proposed activities?
- 9. How would the link be funded?
- 10. How would the link be supported and resourced?

Once received, this information is reviewed by the International Development Working Party. The Working Party determines whether we should pursue a

new link and if so on what basis i.e. good practice exchange or Memorandum of Understanding with a view to a formal twinning in the future. Generally speaking, twinning is a long process based on relationships, which develop over time. Whilst the International Development Working Party can recommend twinning, it would also need to be endorsed by Cabinet and approved by full Council.

Leicester is currently twinned with Strasbourg (France), Krefeld (Germany), Haskovo (Bulgaria), Rajkot (India), Masaya (Nicaragua) and Chongqing (China). If you would like to learn more about Leicester's twinning links, go to www.leicester.gov.uk/twinning/
