### **ANSWER:**

Please see below for the scoring from the Inductive Reasoning Test. I can confirm that we also hold the other information you have requested. However we are withholding that information since we consider that to be an absolute exemption under section 40(2) (personal data), and this therefore constitutes a refusal under section 17 of the Freedom of information Act 2000.

Candidate 1 = Score 10

Candidate 2 = Score 9

Candidate 3 = Score 8

Candidate 4 = Score 7

Candidate 5 = Score 6

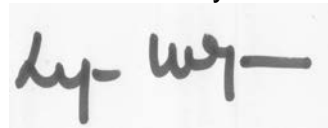
