Your request for information has now been considered and the Council's response to your questions is shown below.

## You asked:

a) the total number of affordable housing units within the local authority area for each of the following years – 2008/9, 2009/10, 2010/11, 2011/12

New Affordable Housing (Intermediate & Social) 2008/09 – 132 2009/10 – 166 2010/11 – 430 2011/12 – 171

b) within the figures for (a), the total number of social rented housing units for the following years – 2008/9, 2009/10, 2010/11, 2011/12

New SOCIAL housing 2008/09 – 76 2009/10 – 68 2010/11 – 381 2011/12 – 132

c) the number of new-build units approved in the local authority area in each of the following years – 2008/9, 2009/10, 2010/11, 2011/12

Below is a table setting out total housing approvals by year (monitoring year = April to March). The data includes conversions and changes of use as well as new build. It includes approvals with outline and full planning permission. We have also shown this data with and without self-contained student units. We would class these as dwellings (as per Government guidance) however we would exclude them from data on affordable housing as we do not expect student housing to provide affordable housing.

Average waiting time was 525 days

g) the longest waiting time of any one person housed by the local authority in social housing during 2011/12

Longest waiting time was 5081 days

h) the average number of people applying to rent social housing property during 2011/12

Average of 212 applications received per week

i) the maximum number of people who applied to rent a particular social housing property during 2011/12

A 2 bedroom house attracted the most bids of 266 from all property types in 2011/12

j) the number of pre-existing social rented housing units that became available for new tenants (e.g. previous tenant moved out) during 2011/12

2125 social lets (not including HomeCome) for 2011/12 but this includes new builds as well.
