

FREEDOM OF INFORMATION ACT 2000 - Bus Services

Your request for information has now been considered and the Council's response to your questions is shown below.

You asked: Follow on question to Foia 5946 – would like clarification on the answers to the two questions below.

In question 4 I ask about bus services cut and you list 7 buses. At question 5 I ask about passenger journeys at risk. **I read this to mean that 361000 journeys are at risk as a result of these 7 listed bus cuts.**

Have I understood that correctly? Or is it the case that on top of the 7 bus cuts that have already happened and that are listed there are other cuts in the pipe line and once these have been fully implemented the number of journeys at risk will be brought up to up to 361000.

These are the two questions and answers from the previous request:

4. If you can provide a list of the services in question and how they have been or will be affected please let us know.

[Answer: The services concerned were First's 16, 18, 21, 22, 74 and 94 and Arriva 104.](#)

5. Have you calculated the number of bus passenger journeys the changes in subsidy could impact once your cuts have been fully implemented? If yes please state the number. I would like to know how many are at risk even if there is a chance that the operator will in fact run the service commercially going forward.

[Answer: The number of bus passenger journeys at risk is estimated at 361,000.](#)

[Answer:](#) It is the case that on top of the 7 bus cuts that have already happened and are listed, there are other cuts in the pipe line. Once these have been fully implemented the number of journeys at risk will be brought up to up to 361000.


