You asked:

I am working for a research consultancy, Credo Analytics, and am currently researching contracts obtained by the company WSP Development and Transportation.

Under the Freedom of Information Act 2000 I seek information about a framework agreement which the PfS issued to WSP Development and Transportation, amongst other firms, for their role on the agreement: UK-Leicester: lead consultant - public realm improvements, city centre development project ("ccdp").

- 1. What contracts have WSP Development and Transportation been awarded as part of this agreement?**

ANSWER

The only contract awarded to WSP Development and Transportation was for work as set out in the Contract Agreement for High Street in Leicester.

- 2. What is the total value of contracts awarded to WSP Development and Transportation?**

As set out in the Contract Agreement the value of the contract was £507,996.


