

FREEDOM OF INFORMATION ACT 2000

Your request for information has now been considered and the Council's response to your questions is shown below.

You asked:

We are currently carrying out analysis into the provision of care to elderly persons. In order to assist in our work, please would you be able to provide the following information? The information should be readily available from the relevant department with responsibility for social care.

- 1. Does the local authority own any care homes registered to provide nursing or residential care to the elderly?**

If the answer to the above is No, please respond to that effect without the need to complete the following. If the answer is Yes, please also respond to the following:

The local authority currently own 8 residential care homes registered Care Quality Commission (CQC) providing care for the elderly. There is additionally a ninth home, also registered with CQC for the purposes of Intermediate Care activity and is short stay only and is not age specific. The council does not provide nursing care.

- 2. Is the care provided by local authority employees or is the home operated by an independent body by way of lease or management agreement?**

Care is provided by local authority staff. The council does not have lease or management agreements with independent bodies for care provision.

- 3. Is there any strategy in place at present to close or sell the homes as going concerns?**

Following the statutory consultation in 2011, and the in-depth review carried out by the Scrutiny Commission, the council is considering a way forward for its residential homes. Change will be carefully introduced and planned over the next three years. During the next three years the council will continue to provide some direct provision, but the Council does not intend to provide residential services in the long term.
