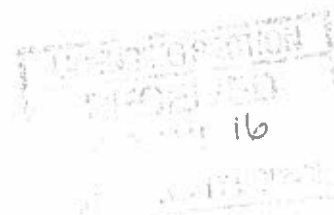

Pre-licensing visit to Reptopia, 62 Church Gate, Leicester

Dear Sir,

I visited this shop on 16/12/15 and today in order to carry out the pre-licensing inspection. On the first occasion the shop was in a very early stage of preparation. Today I met _____ and _____ who between them will run the shop. _____ will be the shop manager. I have been through the Model Standards for Pet Shop License Conditions that have been drawn up from the Pet Animals Act 1951.

Both _____ and _____ have formal training in the care of pet animals within a pet shop, and _____ in addition has considerable experience with reptiles. I am satisfied that they have sufficient expertise and they plan to have at least one of them in the shop whenever it is open.

At the time of my visit today one bank of vivaria had been fitted, but still awaited the installation of necessary lighting and heating. Further vivaria are on order and will be fitted as they arrive. The vivaria that I saw were of a high professional standard.

I went through the following topics with _____ and _____ the keeping of records, stocking densities, food storage, daily routine and care of animals on closed days, waste disposal, transportation of animals, pet care advice leaflets, and the need for fire extinguishers, fire drill protocol, the display of an emergency number, and of the LCC license. They have fire extinguishers but servicing is required.

Although the shop is not yet finished, I am happy to recommend that you grant a license for the keeping of animals as set out below, but also recommend that someone carries out a further inspection once the shop has been open for about a month (in about 6-8 weeks time).

_____ requested that the following stock be included in the license. _____ assured me that no venomous animals would be kept.

8 Tortoises. 40 Snakes. 40 Lizards. 6 Turtles. 20 Frogs. 200 Snails
6 Spiders. 10 Mantises. 20 Millipedes. 6 Crabs. 6 Scorpions
4 Axolotls. 4 Pigmy Hedgehogs.
