THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (COACH PARKING VARIOUS STREETS) (No. 217) ORDER 2017

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 32, 35, 45, 46, 46A, 47, 48, 49, 51, 53 and 63A of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Coach Parking Various Streets) (No. 217) Order 2017 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 26th March 2017.
2.
 - (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to

Causeway Lane	Charles Street
Granby Street	Queen Street
Southgates South Bound Slip Road	St Georges Street
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order
4. In section 4 of the Principal Order entitled Parking Place Restrictions after part 312 insert Schedule 2 hereto
5. In paragraph 2) (ii) of section 1 of the Principal Order, entitled 'General', insert Schedule 3 hereto in alphabetical order
6. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

COACH PARKING PLACE

No person shall cause or permit a vehicle to wait or to load or unload at any time on any of the roads or lengths of road specified to which this restriction is applied except for motor vehicles constructed or adapted to carry more than 8 passengers (exclusive of the driver), displaying a valid permit.

Vehicles must be parked wholly within the parking bay marked on the carriageway.

Failure to display a valid permit or exceeding the maximum permitted stay shall render the driver liable to a penalty charge as set out in section 9 of this order.

Whilst parked in the parking bay no person shall carry out any work relating to the construction or repair of the vehicle other than may be necessary to enable the vehicle to be moved from the parking bay. No person shall allow a vehicle waiting in the parking bay to be used for or in connection with the sale of any vehicle or any other article or for the offer of any service or reward.

The driver must remain with the vehicle at all times when passengers are on-board.

Part 314

COACH PICK-UP/SET-DOWN PLACE

3i, 3ii, 3iii,

No person shall cause or permit a vehicle to wait or to load or unload at any time on any of the roads or lengths of road specified to which this restriction is applied except for motor vehicles constructed or adapted to carry more than 8 passengers (exclusive of the driver) for a maximum period of 30 minutes or to return to the same length of restriction within the next consecutive 1 hour period.

Vehicles must be parked wholly within the parking bay marked on the carriageway.

Exceeding the maximum permitted stay shall render the driver liable to a penalty charge as set out in section 9 of this order.

Whilst parked in the parking bay no person shall carry out any work relating to the construction or repair of the vehicle other than may be necessary to enable the vehicle to be moved from the parking bay. No person shall allow a vehicle waiting in the parking bay to be used for or in connection with the sale of any vehicle or any other article or for the offer of any service or reward.

The driver must remain with the vehicle at all times when passengers are on-board.

SCHEDULE 3

A "Coach" is legally defined as a "Bus" which means a motor vehicle constructed or adapted to carry more than 8 passengers (exclusive of the driver).
