Dear Trustees & Members of the Management Committee,

I hope this email finds you well. I am writing to address a concerning issue regarding the Sikh Community Centre, which has been an integral part of the Guru Tegh Bahadur Gurdwara premises at 106 East Park Road, Leicester LE5 4QB for over 35 years.

Earlier this evening, our administrative officer informed us that some members of the Guru Tegh Bahadur Gurdwara management committee mentioned their intention to "Shut down the Community Centre," and there is a concern that the entrance to the community centre may have been locked. This action, if true, would prevent access to the facilities.

As a Nonprofit Organisation that is registered at Companies House, we have always valued our collaborative relationship with the Gurdwara in serving the community. It is imperative to remind the committee that the community centre provides essential services to some of the most vulnerable and needy members of our community. Among the valuable services we offer, our OFSTED registered 'Roseberry Preschool' nursery currently supports 43 children who attend regularly. Additionally, we provide crucial support to 12 vulnerable adults who are registered with Leicester City Council Social Services for respite and daily living support. These services are vital for the well-being and care of our community's most vulnerable members.

In the event that there is a decision to evict us from the premises, it is crucial to understand that eviction without proper notice would be illegal under UK law. **The Protection from Eviction Act 1977** mandates that any eviction must follow due legal process, including providing adequate notice to tenants. We trust that any actions taken will adhere to these legal requirements and prioritise the welfare of those who depend on the services provided by the community centre.

We sincerely hope that this situation can be clarified swiftly and that any misunderstandings regarding the status of the community centre can be resolved amicably. We kindly request your immediate attention to this matter to ensure the continued provision of essential services to our community members.

Thank you for considering this urgent matter. I look forward to your prompt response via email and the resolution of this issue.
