

How To find LCC Planning Documents

The planning database is available on the following link, <https://planning.leicester.gov.uk/>
This will take you to the screen below. Enter the application number or address.

Search the Online Register

Our online register allows you to check the progress and view a list of current and determined planning applications and appeals or find details of enforcement notices. You should be able to view plans and documents from applications from mid 2006 onwards and decision notices. Tip - If you don't have the application reference number then it is generally more reliable to search by map rather than by address which can change over time.
