## **STATEMENT OF REQUIREMENTS**

#### Introduction

Leicester City Council (LCC) wishes to appoint a single provider to enter a contract for the provision of "next generation" Wi-Fi and support services to replace their legacy wireless network equipment across our corporate estate. The contract term will be for a period of five (5) years.

The objective of this contract is to initially replace all the existing end of life Wi-Fi controllers at the Councils Data Centre and initially deploy and replace the Wi-FI access points with next generation Wi-Fi 6 enabled units across the following sites only:

- City Hall
- Halford House

Subsequent sites and the purchase of the associated Wi-FI access points will be undertaken as further phases and the council reserves the right to purchase these under this agreement following an agreed change control process. The anticipated number of subsequent sites is up to 40 or 50 however, this is neither promised nor guaranteed.

The support services must be through Cisco either directly or partner initiated, and for the term of 5 years.

Tenderers must submit their own Terms & Conditions as part of their Tender submission', noting the Council's minimum requirement of the inclusion of the following terms as below.

#### 1. Insurance

- 1.1 The Supplier shall at its own cost effect and maintain with a reputable insurance company a policy or policies of insurance providing as a minimum the following levels of cover:
  - a) public liability insurance with a limit of indemnity of not less than £5,000,000.00 (five million pounds) in relation to any one claim or series of claims;
  - b) employer's liability insurance with a limit of indemnity of not less than £5,000,000.00 (five million pounds) in accordance with Employer's liability (Compulsory Insurance) Act 1969 and any statutory orders thereunder in relation to any one claim or series of claims; and
  - c) Professional Indemnity Insurance with a limit of indemnity of not less than £2,000,000.00 (two million pounds) in relation to any one claim or series of claims

d) Product Liability Insurance with a limit of liability of not less than £2,000,000.00 (two million pounds) in relation to any one claim or series of claims

(the Required Insurances) in respect of all risks which may be incurred by the Supplier, arising out of the Supplier's performance of this Agreement, including death or personal injury, loss of or damage to property or any other loss. Such policies shall include cover in respect of any financial loss arising from any advice given or omitted to be given by the Supplier.

- 1.2 The Supplier shall give the Council, on request, copies of all insurance policies referred to in this clause or a broker's verification of insurance to demonstrate that the Required Insurances are in place, together with receipts or other evidence of payment of the latest premiums due under those policies.
- 1.3 If, for whatever reason, the Supplier fails to give effect to and maintain the Required Insurances, the Council may make alternative arrangements to protect its interests and may recover the costs of such arrangements from the Supplier.
- 1.4 The terms of any insurance or the amount of cover shall not relieve the Supplier of any liabilities under this Agreement.
- 1.5 The Supplier shall hold and maintain the Required Insurances during the term of this Agreement.

#### 2. Termination on notice

- 2.1 The Council may terminate this Agreement for convenience at any time on giving six months written notice to the Supplier.
- 2.2 This right of termination is in addition to any other rights of the Council under this Agreement and its exercise shall be without prejudice to any claim, remedy or right of action that either party may have in relation to this Agreement.

It is noted that the capitalised wording in the above clauses may need to be amended to ensure consistency of terminology with the terms and conditions. Suppliers must note that the above clauses are required and as such suppliers shall such ensure they are not proposing any provisions which may directly or indirectly affect these minimum requirements.

The Council will not enter into detailed discussion of the Service requirements at this stage. If the Council considers any question or request for clarification to be of material significance, both the query and the response will be communicated, in a suitably anonymous form, to all potential providers who have expressed an interest.
